ASHLEY McGRAW ARCHITECTS: The Westhill Central School District's Cherry Road Elementary School addition has received LEED Silver certification from the U.S. Green Building Council. LEED, or Leadership in Energy and Environmental Design, is a rating system that recognizes excellence in green building design and construction -- including schools. The 32,000-square foot Cherry Road Elementary addition, designed by Ashley McGraw Architects of Syracuse, consists of seven classrooms, a gymnasium, locker rooms, physical education office, music room and a teachers'conference room.
