ASHLEY McGRAW ARCHITECTS: The Altmar-Parish-Williamstown Central School District's Elementary School and Junior-Senior High School additions have been LEED Certified by the United States Green Building Council. LEED, or Leadership in Energy and Environmental Design, is a rating system that recognizes excellence in green building design and construction. The additions were part of a \$34.8 million capital project that reconfigured the district's existing campus to better suit their evolving needs and enhance the district's sustainability. At the elementary school, 16 new classrooms were constructed in two separate wing additions and both the kitchen and cafeteria were expanded. The junior/senior high school addition was LEED Silver certified by the USGBC. At the junior-senior high school, eight classrooms were added, as well as a media center and a technology classroom. <u>CLICK HERE TO READ ARTICLE.</u>



BOND, SCHOENECK & KING: On May 14, in *J.G.S. v. Bellmore-Merrick Central High School District,* the New York State Supreme Court in Nassau County held that the parents of a minor student could proceed with their lawsuit against the school district alleging that their daughter, an eighth-grade student who attends a private school, was bullied by two of the district's middle school students. This case is significant: It is the first time a court has suggested that the Dignity for All Students Act (DASA) provides for a private right of action against school districts. In addition, the decision addresses the scope of a school district's obligations under DASA to respond to harassment of students who do not attend public schools. The court's ruling in *Bellmore-Merrick* is not binding on school districts outside of Nassau County, but it serves as a reminder of the potential liability school districts may face in connection with incidents of harassment or bullying.
