New Yorkers for Students' Educational Rights Win Settlement with NYS, But Much More Work Still Needs to Be Done

For the last seven years the Statewide School Finance Consortium has been a co-litigant in the *New Yorkers for Students' Educational Rights v. State of New York* lawsuit. The suit was our best effort and chance to secure full Foundation Aid Funding. That perseverance and the presence of several important allies has paid off. An agreement to settle the lawsuit has been signed off, contingent on the State keeping its commitment to fully pay out about \$4.2 billion in school aid over three years.

Our press release notes, "If the State honors its commitments, the case will be dismissed. If not, the Plaintiffs will be able to continue the litigation

and seek an expedited trial to secure the promised funding. Plaintiffs believe today's agreement will be an important enforcement mechanism to ensure that the State lives up to its constitutional obligation to adequately fund a sound basic education for all New York students."

A commitment from Governor Kathy Hochul acknowledged that "...the State is no longer pursuing the Foundation Aid lawsuit [NYSER v. State of New York] that occupied many people's time. ... That legal battle is over and...we have officially settled the lawsuit. ... The money was put in the budget last time; we will make sure the money is there going forward."

his ongoing 2014 litigation, sought to require New York State to fully fund the Foundation Aid formula that was put into place following the historic Campaign for Fiscal Equity cases. The litigations had been opposed to by the state. The Foundation Aid formula was created in 2007, and although not perfect, takes school district wealth and student need into account to create a more equitable distribution of state funding to schools. New York State has never fully funded the Foundation Aid formula.

This has been a long battle as our press release indicates. "The case was brought by New Yorkers for Students' Educational Rights (NYSER), a coalition of parents, students and groups representing other stakeholders in the public education system, as well as a number of individual parents. The plaintiffs—represented by pro bono counsel at the law firms Morgan Lewis & Bockius and White & Case; Michael A. Rebell, Esq., a Professor and Executive Director of the Center for Educational Equity at Teachers College, Columbia University and the Education Law Center—filed NYSER v. State of New York in 2014 to compel the State to fully fund the Foundation Aid formula, the school funding system established in the landmark Campaign for Fiscal Equity (CFE) v. State of New York decision."

This coalition proved to be very influential and powerful. "The NYSER coalition includes major statewide organizations such as the New York State School Boards Association, the New York State Council of School Superintendents, the New York State PTA, the New York State Association of School Business Officials, **The Statewide School Finance Consortium**, the Rural Schools Association, Reform Education Finance Inequities Today (R.E.F.I.T.), 13 of New York's Community Education Councils, and other parent and educational advocacy groups from New York City and around the state. Individual parents from the Schenectady school district joined New York City parents and students as plaintiffs in the case."

Michael Rebell, co-counsel for the plaintiffs stated, "Unequal funding has been a blight on education in New York State since DeWitt Clinton was governor. We still have a great deal of work to do. But this was a big first step. The state now needs to update and improve the Foundation Aid formula that was based on a calculation made 15 years ago in order to provide all students the opportunity for a sound basic education guaranteed to them by the state constitution. We need a new system that will ensure adequate and equitable funding for all students on a permanent, stable basis for the future."

Jay Worona, the President of NYSER and Deputy Executive Director of the New York State School Boards Association, said that "Our members and the millions of school children throughout the state who they represent deeply appreciate the great effort and many long hours that the law firms and attorneys who representing NYSER have devoted to this case on a pro bono basis."

If you recall, based on the 2021-22 budget the state indicated its willingness to fully fund the Foundation Aid formula by Fiscal Year 2024. That plan was to ensure that School districts would receive half of their Foundation Aid still due in 2022-2023 and be fully funded by 2023-2024. The newly signed agreement confirms that commitment.

A breakdown provided by the Governor's office of anticipated Foundation Aid availability is below:

- FY 2022: \$19.8 billion, covering 30% of the existing shortfall
- FY 2023: Approximately \$21.3 billion, covering 50% of the anticipated shortfall
- FY 2024: Approximately \$23.2 billion, eliminating the anticipated shortfall, and funding the full amount of Foundation Aid for all school districts

Make no mistake this is a momentous achievement, but more work needs to be done. Critical elements of the Foundation Aid formular need revision, and updates are needed for it to truly represent the needs of all school districts.

Additionally, hundreds of school districts, for whom the Foundation Aid formula as implemented to date, are considered "fully funded" or even "save-harmless". How much of an increase over the next two years those districts will receive is anyone's guess. Based on the current and recent state budget increases, future increases could be muted. With the current inflation trends and limitations of the tax cap all is not necessarily rosy for every district into the future. Expense driven aids (i.e., BOCES, Building, Transportation Aids) will also tap state resources over time. We remain concerned about the State's finances in the 2024-25 and 2025-26 fiscal years.

Make no mistake, we at SSFC will continue to battle for increased equity, adequacy, predictability, and sustainability of a Foundation Aid formula and other state support for our member school districts!
